3. **Representation must be accompanied with a treasury receipt of Rs. 500/- deposited within given time.** Those who file representation will be provided an opportunity of personal hearing before the Commission for redressal of grievances, after conduct of CSS MPT-2022.
4. A candidate whose candidature has been rejected, even if allowed to appear in the examination, **his/her result shall not be announced in terms of Rule 16 (6) of CE Rules-2019, unless found eligible.**
5. You are advised to read CE Rules carefully as your representation will be decided strictly in accordance with these Rules.
